

**ORDER**

Amending the Annex of the Order no. 5140/2019 of the Minister of Education, from September 11, 2019, for the approval of the Methodology regarding the academic mobility of students,

Given the provisions

- art. 142, 147, 199, 200, 222, 224 of the National Education Law no. 1/2011, with subsequent amendments and additions and

- Law no.1 / 2010 for the approval of the Government Ordinance no. 22/2009 on establishing the minimum amount of tuition fees, in foreign currency, for citizens studying on their own account in Romania, from states that are not members of the European Union, as well as from those that are not part of the European Economic Area and the Swiss Confederation,

Considering the Report no. 470 / DGRIAE / 02.03.2022,

Taking into account the provisions of art. 7 of the Convention on the Recognition of Higher Education Certificates in the States of the European Region, adopted in Lisbon on April 11, 1997, ratified by Law no. 172/1998,

Pursuant to the provisions of art. 13, paragraph (3) of H.G. no. 369/2021 on the organization and functioning of the Ministry of Education, with subsequent amendments and additions,

MINISTRY OF EDUCATION**issues the ORDER:**

Art. I Annex to the Order of the Minister of Education no. 5140/2019 of September 11, 2019 for the approval of the Methodology regarding the academic mobility of students is amended as follows:

1. Art. 3, two new paragraphs are introduced, paragraph (2) and (3) which shall have the following content:

„ (2) If the student or doctoral student cannot prove the studies completed by documents issued by the higher education institution he / she previously attended in Ukraine, the higher education institution in Romania will evaluate, based on its own criteria and in compliance with good international practices, learning outcomes, competencies and skills and decides on the recognition and award of transferable study credits.

(3) The student or doctoral student in the situation mentioned in paragraph (2) will present to the higher education institution in Romania, before completing his / her studies, the diplomas that allowed him / her access to the study cycle in which he / she was enrolled.”

2. After art.4 a new article is introduced, art. 4 ^ 1 with the following content:

„ Art. 4 ^ 1 By way of derogation from the provisions of Article 4 in the academic years 2021-2022 and 2022-2023, academic mobility for citizens of third countries of the European Union,

who come from recognized higher education institutions in Ukraine, can be done at the request of the student, with the consent of the receiving institution. "

3. Art. 10 after paragraph (2), two new paragraphs are introduced, paragraph (3) and (4) which shall have the following content:

„(3) Tuition fees are applicable to the final academic mobility of the students mentioned in art. 4 ^ 1 and the level of fees is established according to Law no.1 / 2010 for the approval of the Government Ordinance no. 22/2009 on establishing the minimum amount of tuition fees, in foreign currency, for citizens studying on their own in Romania, from states that are not members of the European Union, as well as from those that are not part of the European Economic Area and the Swiss Confederation.

(4) In the academic years 2021-2022 and 2022-2023, with the exception of the provisions of paragraph (3), the students, citizens of Ukraine, may benefit from funding from the state budget or from other sources, through the Ministry of Education and higher education institutions, according to art.224 of the Law no.1 / 2011 of the national education, with the subsequent modifications and additions.”
